459 Truck came in for possible fan clutch not working as well as to do a DOT. Did DOT inspection on this line. Found fan clutch relay wiring pulled extremely tight and pin not making good contact in relay. Flxed. Fan clutch works but bus still wants to occasionally overheat. Got with customer on bus and discussed it with them. Put thermal imager on bus and found radiator is clogged. Got approval from customer. Had to flush entire coolant system for engine and bus as coolant was extremely contaminated. R&R radiator, checked thermostat while out, and put fresh coolant in bus. Topped off transmission fluid and ran engine to operating temp. No leaks were found. Test drove, engine never over heated and fan works as it should.
